

Batam Trauma Center in Supporting Industries

Batam is the best choice for investment, it's shown that Investment in Batam is increasing. This is an achievement of investment realization that hit the target. This moment is directly proportional to the growth of new industries that have emerged. BP Batam is committed to developing industrial areas especially for potential investors and infrastructure development continues to be a real effort to increase investment.

BP Batam also put more concern to the quality of safety in the field of human resources. In accordance with the mandate of Law no. 1 of 1970 concerning Occupational Health and Safety or better known as Occupational Health and Safety (OHS). Every industry must pay attention and implement OHS in work environment. The function of OHS on a micro scale is to protect workers from the threat of workplace accidents. On a macro scale, the implementation of OHS prevents big losses for a company.

Considering that there are still many incidents of unsafe conditions and unsafe behavior in the industrial world, this situation is not beneficial for both parties. Responding to this phenomenon, as a form of support by BP Batam to the industrial world, a trauma center was built at BP Batam Hospital (RSBP). The construction of a trauma center is a form of medical support in the event of a trauma incident in an industrial area.

The construction and improvement of trauma center infrastructure at RSBP is also expected to be able to boost investment. The trauma center which is integrated with RSBP tries to provide the best service. The quality of the health workers also has a certification of expertise in the field of trauma at the national level. So there is no need to doubt about the service.

The trauma center services available at RSBP include Surgical Oncology Sub-Specialists, Digestive Surgery Sub-specialists, Gynecological Oncology Sub-Specialists, Pediatric Emergency Sub-Specialists, Viteoretinal Eye Specialists, Neurosurgery, Orthopedic Surgery, Thoracic Surgery, Surgery General, Pediatric Surgery, Oral Surgery, Urology Specialist, Ear Nose Throat (ENT) Specialist and Eye Specialist. The highest quality medical equipment to support trauma center operations was also brought in. Some of them are CT-Scan 128 Slices. This type is the best of its category. Then there is also Auto Pulse, 4D Ultrasound, and Cath Lab. All of them are prepared to deal with trauma cases.

INDONESIAN AMBASSADOR FOR ROMANIA VISIT BP BATAM


Badan Pengusahaan Batam (BP Batam) received a working visit from Embassy of The Republic of Indonesia (KBRI) for Romania on Monday, 31 May 2021 at BP Batam Marketing Center. This delegation was led directly by the Ambassador of the Republic of Indonesia to Romania, H.E. M. Amhar Azeth, accompanied by the Honorary Consul of the Republic of Indonesia for Constanta, Romania, Emil Sirbu; Secretary for Economic Relations of the Indonesian Embassy in Romania, Regia Mutiara Rozuah; and representatives of the Indonesian Ministry of Foreign Affairs, Hermawan.

The Chairman of BP Batam, Muhammad Rudi, accompanied by Deputy chairman for Regional Management and Investment, Sudirman Saad and Deputy Chairman for Enterprise Management, Syahril Japarin; welcomed the delegation directly. Batam City Government delegation also attend this meeting.

The focus of the discussion in this visit is the possibility of cooperation and investment which is expected to be established between Batam and Romania. Muhammad Rudi said that Batam opens up many opportunities for investment. The Ambassador, said that Romania has a long history with Indonesia since independence.

Romania also has a lot of potential that can be developed in cooperation between the two regions. Romania is one of the countries that supported Indonesia in achieving its independence at the United Nations 73 years ago. Relations between Indonesia and Romania are also very cordial in international forums, and it can be continuing this positive synergy with Batam.

Romania is a country of agriculture, plantations, livestock and industry. Examples of growing industries in Romania include Airbus helicopter manufacturing and ship repair manufacturing. As for the health sector, Romania has a cancer research center, Romania also has a good water and waste management system.

SITE VISIT TO BP BATAM WASTEWATER AND FINAL DISPOSAL SITE

After meeting with The Chairman of BP Batam, The Ambassador accompanied by several officials from the Batam City Government Environmental Service, visited the Waste Water Treatment Plan (WWTP) BP Batam and Final Disposal Site (TPA) Telaga Punggur.

The Ambassador received a direct explanation of the concept of (WWTP) development in Batam from BP Batam's Environmental Management Manager, Iyus Rusmana.

WWTP in Bengkong Sadai and 5 pumping stations have been 100% completed and will operate when the main pipeline installation has been completed. The WWTP in Bengkong Sadai is a center for domestic waste treatment from the Batam Center area and forward to the Bengkong area. Later, this waste will be collected to the pumping station and WWTP, then decomposed and processed into fertilizer and raw water reservoirs for daily needs, after being netted.

Romania also has a special law on weather modification systems. considering that Batam has used Weather Modification Technology (TMC) to increase the volume of raw water in the reservoir. Embassy to Romania on the plan for cooperation between the two regions, one of the investors will open one of its representative offices in Batam.

The Romania embassy have coordinated with one of the Romanian investors in the near future, if the licensing management is complete, a representative office for ASEAN countries will be opened in Batam, specifically in the TMC sector. (NC)

BATAM PORT BUSINESS ENTITY IMPLEMENTS B-SIMS




The Port Business Entity of Badan Pengusahaan Batam (BP Batam) (Badan Usaha Pelabuhan BP Batam (BUP) has again strengthened the application of information technology in port services. As of 14 July 2021, BUP officially implemented online-based services using the B-SIMS (BP Batam Seaport Information Management System) application stipulated through the Circular Letter of the Director of the Port Business Entity Number 9 of 2021 on 11 June 2021.

Director of BUP BP Batam, Nelson Idris, said the implementation of B-SIMS aims to improve port services by the value of Dedication (Leading, Dynamic, Collaborative, and Integrated), which is the work culture of BUP BP Batam. As a result, the service users no longer needed to come to the port to manage Ship General Statement (Pernyataan Umum Kapal, PUK) and monitor the note's status where it has reached, so it can be said that port services at BUP have implemented a digitization system.

B-SIMS application was integrated with the Inaportnet system carried out by the Directorate General of Sea Transportation of the Ministry of Transportation. Moreover, B-SIMS will also be integrated with the Auto Gate System and TPS Online, part of the Batam Logistic Ecosystem (BLE). It aims to speed up the flow of goods in and out at the port. With this in mind, digitalization will reduce the costs incurred by service users so that it hopes to stimulate the economy, especially the reduction of logistics tariffs. In addition, during the one month trial period and two weeks of the official implementation of B-SIMS, there were no long queues of service users at the BUP Office. At the pandemic, online services were deemed essential and considered the best solution for service users and officers to prevent the spread of Covid-19.

The implementation of B-SIMS is an effort by BP Batam under the leadership of the Chairman, Muhammad Rudi, to facilitate and accelerate administrative services for managing goods and passenger ships, hoping that entrepreneurs can grow faster and have a positive impact on the economy of Batam.(FD)



World's Largest Floating Solar Farm

•Energy Storage System Will be Built in Batam•

Batam has started to focus on using renewable energy, this is to participate in reducing the use of carbon emissions which has begun to become a worldwide concern. This is realized by the construction of the world's largest floating solar panel in Batam. BP Batam signed 2 MoU's, the first with SunSeap Group which was signed on Monday, 19 July 2021 virtually by the Head of BP Batam, Muhammad Rudi, and Co-Funder and CEO of Sunseap Group Pte. Ltd., Frank Phuan. With an estimated investment value of USD 2 Billion. Sunseap Group is Singapore's largest and most established clean energy solutions provider, with regional operations in South East Asia Pacific.



The second BP Batam signed an MoU with PT. Toba Bara Energi on Thursday (12/08/2021), this MoU was attended by the Head of BP Batam, Muhammad Rudi, and the President Director of PT. Toba Bara Energi, Dimas Adi Wibowo. Also attending the signing was the Commissioner of PT Toba Bara Energi, Nizar Rachman; Deputy Head of BP Batam, Purwiyanto; Member of BP Batam Administration, Wahjoe Triwidijo Koentjoro; Member of BP Batam's Area Management and Investment Division, Sudirman Saad; Member of BP Batam's Business Sector, Syahril Japarin. With an investment value of USD 470 million. PT. Toba Bara Energi will be building a Floating Photovoltaic System (FPV) on the Tembesi reservoir and is projected to have a capacity of 333 MWp

SunSeap Group will be building a Floating Photovoltaic System (FPV) with a span of approximately 1,600 hectares and is projected to have a capacity of up to 2.2 GWp. Making it the largest FPV in the world to date. Energy Storage System (ESS) is also slated to be the largest ESS with a storage capacity of larger than 4,000 MWhr. This FPV will be built on the largest reservoir in Batam, the Duriangkang Reservoir, with a water catchment area of more than 7,000 ha.

Sunseap is also planning to set up a Sunseap Academy in Batam, which will see the hiring and skills sets transfer to the locals who will be involved in building the world's largest FPV and ESS. This project will absorb around 3,000 locals. This project will start in 2022 and will be completed in 2024.

This also proves that Batam is still the main destination for investment in Southeast Asia.(IB,GG)

This FPV is estimated to be able to produce more than 2,600 GWh of electricity per year, partly for electricity needs in Batam, and potentially be exported to Singapore using approximately 50km subsea cable. This FPV is equivalent to reducing carbon use by 1.8 million metric tons of carbon per year.

Batam Hang Nadim Airport Becomes Super Air Jet Airlines Flight Route

The Airbus 320-200 Super Air Jet with a capacity of 180 economy class seats officially operates and makes Batam's Hang Nadim Airport one of its commercial flight routes.

The airline, which is part of the Lion Group, made its first flight and inaugural landing at Hang Nadim Airport on Friday, 6 August 2021. The Super Air Jet airline targets Indonesian millennials as its market segmentation. The economy class flight is also preparing several domestic routes that are considered potential because traveling has become a trend for millennials.

The Super Jet crew members accompanied by management were greeted by the General Manager of BUBU Hang Nadim, Benny Syahroni, and the staff in the Hang Nadim Airport.

Captain Ariaga Cakrawala, a Super Air Jet pilot, said the Super Air Jet's inaugural route is Jakarta-Batam at 12.50 WIB and Batam-Jakarta at 15.30 WIB.

"The total number of aircraft in Semester I 2021 is 11,538 aircraft. This number has decreased by -9.82 percent, compared to 2020, where the total aircraft in 2020 were 12,794 aircraft," said Benny. the number of flights dropped due to the global pandemic at the end of 2019, where tourism and aviation businesses were severely affected all over the world. Meanwhile, according to records from Hang Nadim Airport, 555,166 departing passengers and 557,167 arriving passengers were recorded, and 90,199 passengers transited at Hang Nadim Airport.

Super Air Jet offers a low-cost carrier concept with direct flights between cities in Indonesia, and it is possible that in the future it can expand to international routes. It is hoped that when the pandemic is over, Super Jet Airlines will be the solution for millennials to travel by air.(IB)

Changing OSS to Online Single Submission Risk Based Approach (OSS-RBA)

After getting delays in the inauguration due to several reasons, the Online Single Submission (OSS) Risk Based Approach (BSA) was finally inaugurated by President Joko Widodo at the Office of the Investment Coordinating Board (BKPM) on Monday, 9 August 2021. OSS-RBA is a business license granted to business activities actors to start and run their business activities which are assessed based on the level of risk of business activities.

As regulated in the provisions of Government Regulation (Peraturan Pemerintah, PP) Number 5 of 2021 concerning the Implementation of Risk-Based Business licensing. In this OSS-RBA system, the application for business licensing will be assessed at the level of risk and the scale of business activities.

The application of a risk-based approach requires a change in mindset, adjustment of work procedures for the implementation of business licensing services, requiring a re-design of the Business Licensing business process in the electronic licensing system. The risk-based approach is used to determine the type of Business Licensing and the intensity of Supervision. These two things are a package of Government instruments in the context of regulating business activities so that they run well.

There are some significant differences in the OSS-RBA system. First, all business activities in the OSS-RBA system covering 16 sectors have been centralized. Second, the Norms, Standard, Procedures and Criteria (NSPK) for risk-based business licensing in each sector will be used as a single reference in business licensing. Third, OSS-RBA licensing tries to differentiate based on risk and scale of business activities. Fourth, the OSS-RBA licensing has a clear time standard so as to create certainty for business actors.

The licensing level in the OSS-RBA system is divided into three levels, namely low, medium, and high. Therefore, each level has different terms and conditions. Especially, for high-risk businesses, it will refer to the Norms, Standards, Procedures and Criteria (NSPK) guidelines that regulate licensing techniques.

With the inauguration of the OSS-RBA system, it is hoped that investors will find it easier to apply for permits to various parties. This is because, the Minister of Investment, Bahlil Lahadalia said, OSS-RBA is a one-stop licensing application/portal that includes licensing at the district/city, provincial, Ministry/ Agency and Ministry of Investment level

In Batam, Badan Pengusahaan Batam (BP Batam) is an the agency granted access by Investment Coordinating Board (BKPM) to implement OSS-RBA system. After its inauguration some time ago, the relevant agencies need time to develop a system that is in accordance with OSS-RBA.(AW)
